website. There are a total of 163 lessons available for you to view, print, or download. The National FCE website "Members Page" has hundreds of lessons available. You will need a password to get on the page and I can give it to you.

We are again doing the Oregon FCE High School Age CHARTACTERCOUNTS!© Essay Contest. Starting this year, it is a State and National contest. Lots of work has been done about getting the information out to high school age students. We don't have a count of how many are participating because the deadline is March 1, 2025, for the contest entries. I am sure we are going to have a lot of entries this year. FCE is well and alive. I'm hearing of various FCE and volunteer activities from across the state of Oregon and across the nation. Lots of lessons are being given and lots of learning is going on. We may be few in numbers, but we are all strong in spirit and dedication to FCE. Keep up the great work.

We were again able to hold an "in person" 2024 Oregon FCE State Conference this past year and all those attending had a great time visiting, socializing, and getting to see everyone. The Conference was held at the Hilton Garden Inn in Springfield.

The State Board, the Conference Committee, and lots of volunteers took on assignments and did a wonderful job planning and hosting the Conference. It took a "Village" to put it on, but everything went well. A big thank you to all those that helped. The number of attendees was 28 full-time attendees. The excitement was up, and all the Conference evaluations rated it number ONE. Everyone loved the hotel, the hotel workers, the hotel location, and the wonderful food they served. We had great speakers, great classes, wonderful tours of the area, great activities, and games, but most of all we had great friends. We had a great "Country Store" and sold raffle tickets for all the items. The "Country Store" was a big hit and we're doing it again this year.

Everyone met at least one new friend. Some non-FCE friends were invited to attend. At least 2 new members joined FCE because of that loving, sharing, and inviting. If you weren't there, we missed you, and hopefully we'll see you at the Conference this year.

The 2025 Conference is going to be held again at the same location. The contract with the hotel has been signed and we are ready to go. The dates of the 2025 Conference are October 6-8, 2025. The theme of the Conference is "Power of the Past... Beacon to the Future." Your FCE State Board will again do the task of hosting the Conference. They, along with FCE members, Study Groups, Counties, and Districts will take over that task. It worked very well in 2024. They will use help from all around the state of Oregon. There are lots of assignments and tasks that need to be done and most of them have had volunteers step up for them.

We have selected 5 lessons for the Conference including: Great American Women part 3 by Kerry Mauk; Forgotten Towns in Oregon by Sally Wyffels & Lynda Nyseth; Spilling the Beans by Bonnie Teeples & Marian Banes; The Red Cross by Karen Walker; and Prostate Cancer by Scott Teeples. This year all the lessons will be taught in the same room so you can attend all 5 of them.

We are also doing a couple of new things in the schedule. The Board meeting will be held on Sunday afternoon so the Board members can attend the activities on Monday morning. We are also doing something new in doing two service projects on Monday morning including making "Comfort Bears" and "Lap Blankets."

To help with the cost of the State Conference, we are looking for Conference Sponsors including individuals, Study Groups, Counties, and businesses. Please let me know if you have any suggestions for sponsors. I will take care of you by writing them a letter asking for their support.

Let's make sure that we are doing all our normal activities including volunteering, meeting in our Study Groups, County Council meetings, District meetings, and our State Conference. Be sure to schedule and hold those special events that we have had in the past. Please Invite me to your various activities and I'll do all I can to be there.

The Oregon FCE Zoom lessons will continue onward this year. Wednesday February 5, 2025, will be our 50<sup>th</sup> monthly lesson. They are usually held

on the first Wednesday of the month. FCE members and friends of FCE have participated from across the USA. There have been "Guest Presenters" from Oregon, Virginia, West Virginia, Hawaii, Kansas, Florida, Maryland, Tennessee, Nebraska, North Dakota, and Mississippi. All the Zoom Lessons have been recorded and are available on the Oregon website www.oregon-fce.org. Please let me know if you'd be interested in being a presenter.

The 2025 ACWW-USA/National FCE
Conference is going to be held in Erlanger,
Kentucky on July 21-24, 2025. It will be different
than past national conferences because it will be
combined with the Associated Country Women of
the World. This year, the National FCE Alumni
Association is sponsoring 10 National Conference
Scholarships (which pay full registration cost).
Oregon FCE also has some National FCE
Conference Scholarships available. Contact me for

Before I close this President's report, I want to, as I always do, repeat "Scott's Challenge." My challenge to you is to do all that you can do to "Grow" this organization. Yamhill County has 22 FCE members: Amity 10, Creative Homemakers 11 and 1 member-at-large. Marion County has 2 members-at-large.

**Amity FCE** has 10 members. We have a new member this year, Jean Leppin returning after several years.

We had lessons presented by members and Lynda's daughter presenting a lesson giving helpful tips to help us with daily activities as we age. Jeannie is an OT, she likes to problem solve so she asked us "What is hard for you to do in your day? What are you not doing that you want to be able to do?" Many ideas were shared on how to make holding silverware, brushes and other objects easier for us to handle. Exercise ideas were also shared, it was a day full of helpful information.

Late November several of us got together to make our Christmas wreaths to sell to the public and our members. We made 20 plus wreaths. Money raised goes toward buying gifts for the tree of giving that the Amity Fire Department sponsors.

December, we enjoyed our Christmas luncheon at the Black Bear in Newberg. Great way to end 2024.

We started 2025 with a game day. Lots of games, laughter and soups and desserts for lunch and more games.

Volunteer hours October 2024-January 2025: FCE 132 1/2 and Others 228 1/2. These include FCE activities (lesson teaching, hosting meetings, mailing newsletters, Christmas wreath making, County Council, officer duties), Gideons, church, museum, hospital sales room, helping neighbors, knitting and crocheting for museum.

#### **Creative Homemakers** has 11 members.

Both November and December were active within the study group. In November ten members traveled to the Sherwood area to visit "Al's Garden Center". Each year Al's has several acres decorated for the Holidays...Christmas decorations, greenery, trees, flowers in all different colors, plus many other ideas for the season. Following the tour of the center the members had lunch in a Red Robin restaurant. In December the members met at a member's home. They had a gift exchange, potluck luncheon and raised money to be donated to an organization that is helping the people in North Carolina dealing with the areas destructed by the hurricane this past year. In January the group met at another member's home. The study group appointed their new officers for 2025.

**Lane County, Lost Creek FCE** has 9 study group members. They have a new member this year, Donna Ellickson.

Volunteer hours from October thru January are 297 for other hours and 88 ½ for FCE hours. These include making bags of love for Lane County, community gardens, Oakridge Museum (teaching young people how to knit and other museum duties) helping family members, preparing and giving FCE lessons, secretarial work for FCE, making items and baking for their Christmas auction.

One lesson that Ann gave was on how to use egg substitutes since the price of eggs has sky rocketed.

During Christmas time they had three members injured and could not attend the Christmas gathering and auction. Pat Putnam broke her lower leg just before the state conference and is recovering in Alaska at her daughters. Nadine Reed fell and broke her nose and hurt her leg, spent time in the hospital and rehab before returning home and Deanna Hadley tripped and caught herself on her wood stove and received bad burns on the palm of her left hand. She is all healed up now.

Even with members missing we made \$135 at our auction, we donated \$50 to the Dexter Fire Department and \$50 to the Dexter Food Pantry. We brought mostly handmade or baked items to sell to one another.

I presented a hearth fire lesson called "Developing an immune system for the soul" in October, Elsie and Frank gave a lesson called "Your Marvelous Liver" in November.

Here is a good salad recipe that Nadine Reed shared with me. It is called **FuFu Salad.**You mix up 1 small box of pistachio pudding, 1 large can of crushed pineapple with the juice, 1 8 ounce tub of cool whip, and a handful of miniature marshmallows. Enjoy.

Membership is down again this year. The responsibility for membership growth and stability lies with each one of us. Oregon has not had a significant gain in membership since 2011, when there was a gain of 50 members. Since that time, we have lost members EACH and EVERY year.

Due to successful fundraising and the frugality of the board, we have been able to stop the drain on our investments. There is enough in donations to fund two issues of the newsletter and help with the website fees instead of taking money out of the CD's. The longer we can fund these two important items with donations the longer we can keep our investments viable.

Our fundraising booth is paying off. In 2024 we earned over \$1900.00 from booth sales. I would ask that each of us keep donating items to the booth.

Ideas for items that sell well in the store are household items such as Pyrex bowls, wall décor, tabletop décor, lamps, doily's etc. If it is something you would buy for your own home then it will more than likely sell in the store. If it is chipped, cracked, torn or damaged in any way it will not sell.
